## TELEHEALTH NETWORK UPDATE

Hello All:

There are new federal **USAC**/Rural Health Care Division requirements for the **2005** funding year. We need an **FCC registration number** for each hospital to file the form 466 for 2005. Please try to obtain these by September 1, 2005, and e-mail them to Kandi Thomas as soon as possible. You will need your tax ID number to register with the FCC. The registration web site is: <https://svartifoss2.fcc.gov/cores/CoresHome.html> or visit the FCC's web site at [www.fcc.gov](http://www.fcc.gov) and click on the link at the left of the page for FCC Registration Number (FRN) Commission Registration System (CORES). Please call Kandi if you have questions about this process.

We are working on training materials and a training schedule for all of the sites on the network and will have that available as soon as possible. We will try to make programming available to all at the earliest possible convenience. In order to facilitate connections as requested, please make sure you call and schedule participation in any program at least 48 hours in advance so we do not miss getting anyone connected.
